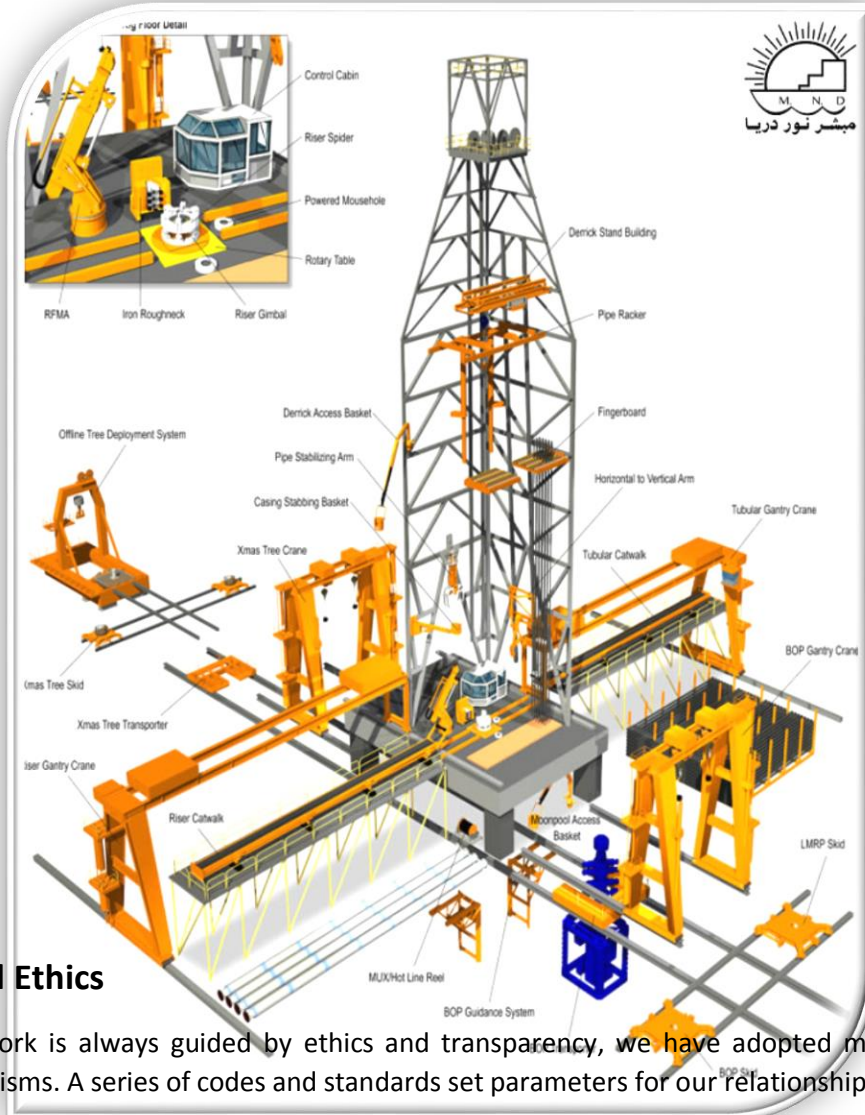
Sustainable Development & Integration
